OCTOBER LUNCHEON BY TRACY JELNECK

For our October luncheon William Hamilton, Senior Fiscal Analyst, House Fiscal Agency, presented a topic on 'Appropriation Process – A Legislative Perspective'. Mr. Hamilton discussed what analysts do at the House Fiscal Agency and their role in the appropriation process and also included a little perspective on the legislative branch.

JANUARY TAX LUNCHEON BY ABDEL ALY

The 2018 Tax Update was presented by Carrie Hindmon, CPA from Andrews Hooper Pavlic. Carrie explained what changes we should be aware of for the 2018 tax reporting. In summary, the key points emphasized were 1) no new lines on the Form 1040, 2) rate, deductions, exemptions indexed for inflation, and 3) due date changes.

FEBRUARY LUNCHEON BY TRACY JELNECK

Terry Stanton, former Lansing TV news anchor, and current Manager of Unclaimed Property presented at the February 2019 luncheon. Terry informed attendees that Michigan is in the top 10 states for returning unclaimed property to its rightful owners. Terry stated that only 10% of businesses report unclaimed property to the State of Michigan and he thinks that it should be much higher. Terry explained that a lot of smaller businesses do not realize that they should be sending those funds from unclaimed paychecks to the State. Unclaimed Property is currently holding over \$2 billion in assets just waiting to be claimed by their rightful owners. So, if someone calls you and says they can help you claim some long lost property in Michigan, forego the 'finders fee' by hanging up the phone and going straight to www.michigan.gov/unclaimedproperty and looking it up yourself.
